

## CONFIDENTIALITY AND IMPARTIALITY COMMITMENT

I commit that,

Do not have any close relations (kinship, friendship, share/partnership, financial investment (including directly holding stocks), employment etc.), which may put endanger my impartiality with the customer, whose conformity assessment activities I will perform. I shall immediately notify SZUTEST Konformitätsbewertungsstelle GmbH in case of the existence of such relations,

I have not been engaged with the client that I have been appointed to within the last 3 years for medical device conformity assessment activities, did not provide consultancy, special training to the customer, or internal auditing services, and have not worked in an organization, providing such services. In case of similar facts, I shall not accept the assignment and immediately notify SZUTEST Konformitätsbewertungsstelle GmbH,

Shall perform the conformity assessment activities, based on objective evidence, equitable, impartial, independent, and honest; to avoid any behavior, which may damage the reputation and prestige of SZUTEST Konformitätsbewertungsstelle GmbH.

Shall not be in a relationship of interest with any person or organization, not claim anything from the person/organization or its representative, I serve to, in my or anybody's favour. In case of such a proposal, I will refuse it and immediately notify SZUTEST Konformitätsbewertungsstelle GmbH,

Shall pay attention to the confidentiality of all data, information, and documents, that belong to SZUTEST Konformitätsbewertungsstelle GmbH and its customers, and not disclose them to third parties except to the authorities responsible for notified bodies, competent authorities for medical devices in the Member States, the Commission or required by law,

I understand all types of information gathered during conformity assessments are classified as confidential,

I will secure and apply professional secrecy on confidential information except in relation to the authorities responsible for notified bodies, competent authorities for medical devices in the Member States, the Commission,

I will follow the confidentiality practices documented in PR.11 Confidentiality Impartiality Objectivity Conflict Of Interest And Risk Analysis Procedure and for medical devices services; PR.MED.37 Medical Devices Procedure for Special Confidentiality Management Rules and will treat the confidential information as documented in these documents,

Shall protect all types of intellectual property rights,

Shall ensure the confidentiality and security of all information and documents, obtained during the performance of conformity assessment services unless these services are completed, not keep them once the conformity assessment process is concluded and delivered to SZUTEST Konformitätsbewertungsstelle GmbH to be saved in its file,

Shall not engage in any activity, which may affect my impartiality and independence within the scope of the conformity assessment I will be performing,

I am not a designer, manufacturer, supplier, installer, purchaser and/or owner, maintainer, or consultant of devices which I assess, nor the authorised representative of any of those parties, and I do not represent any parties engaging with these activities.

I am not directly involved with the products, subject to conformity assessment or other products in competition (such as competing trademarks or manufacturers). In such case, I shall not accept the assignment and immediately notify SZUTEST Konformitätsbewertungsstelle GmbH,

Additional requirements for employees to work in the medical department under (EU)2017/745 Regulation;

-I will not engage in such a close relationship (friendship, etc.) that may jeopardize my impartiality during the conformity assessment activities that I will be assigned. In case of such a situation, I will refuse it and immediately notify SZUTEST Konformitätsbewertungsstelle GmbH,

-I did not provide consultancy, on-site training, internal audit service, technical documentation preparation services to the company, or companies belonging to the same group of companies or its authorized representative or its commercial competitor and supplier to whom I will be assigned for conformity assessment activities in the last 3 years. In case of such a proposal, I will refuse it and immediately notify SZUTEST Konformitätsbewertungsstelle GmbH,

- I have not been involved in the design, production, marketing, installation, maintenance, use or quality management system of the products subject to the conformity assessment that I will be assigned for conformity assessment activities in the last 3 years and I did not represent any parties engaging with these activities.

In case of such a proposal, I will refuse it and immediately notify SZUTEST Konformitätsbewertungsstelle GmbH,

- I did not work in the company which will be audited/assessed or was audited/assessed, and I did not and do not have any commercial connection.

In case of the presence of an activity that will be a valid input to the subject conformity assessment such as being involved with a clinical investigation, scientific study, clinical evaluation, test, etc for the same manufacturer or the sponsor of the subject manufacturer, I will refuse it and immediately notify SZUTEST Konformitätsbewertungsstelle GmbH,
